The water pressure reducing valve shall be constructed using Lead Free\* materials. Lead Free\* regulators shall comply with state codes and standards, where applicable, requiring reduced lead content. The valve shall feature a Lead Free\* cast copper silicon alloy body suitable for water supply pressure up to 300psi (20.7 bar). Provision shall be made to permit the bypass flow of water back through the valve into the main when pressures, due to thermal expansion on the outlet side of the valve, exceed the pressure in the main supply. Pressure reducing valves with built in bypass check valves and integral strainer will be acceptable. Approved valves shall comply with ASSE 1003. Valve shall be a Watts Series LFN45B.
